If you have been ordered to attend the MADD Victim Impact Panel, you will be required to attend on the dates your probation Officer gave you. The following is expected:

THE PANEL WILL BE HELD AT 7 PM IN THE COMMISONERS ROOM AT THE ANNEX (ON THE 2ND FLOOR), LOCATED DIRECTLY BEHIND THE COURT HOUSE.YOUR ATTENDANCE IS A CONDITION OF PROBATION AND IS MANDATORY. IF YOU FAIL TO ATTEND, A PETITION TO REVOKE PROBATION WILL BE FILED WITH THE COURT. YOU MUST ATTEND *THE PANEL SCHEDULED BY A PROBATION OFFICER*, AND IT WILL NOT BE RESCHEDULED FOR ANY REASON.

PLEASE READ THE FOLLOWING INSTRUCTIONS CAREFULLY:

- 1. CHECK IN IS BETWEEN 6:30 AND 7 PM. THE PANEL STARTS PROMPTLY AT 7 PM. IF YOU ARRIVE EVEN FIVE MINUTES LATE, YOU WILL NOT BE ADMITTED. YOU ARE NOT ALLOWED TO LEAVE UNTIL THE PROGRAM IS CONCLUDED.
- 2. YOUNG CHILDREN ARE NOT ALLOWED. BABYSITTING SERVICES ARE NOT PROVIDED.
- 3. ALCOHOL OR ILLEGAL DRUG USE IS STRCTLY PROHIBITED AND WILL NOT BE TOLERATED. ALL PAPRTICIPANTS ARE SUBJECT TO PORTABLE BREATH TESTS.
- 4. PICTURE ID IS REQUIRED.
- 5. THE **\$30.00** FEE WILL BE COLLECTED AT THE DOOR. THE FEE MUST BE PAYED BY **MONEY ORDER** MADE OUT TO **MADD**. NO OTHER FORMS OF PAYMENT WILL BE ACCEPTED.
- 6. DO NOT BRING FOOD OR DRINKS WITH YOU TO THE MEETING.

- 7. DO NOT WEAR ATTIRE WITH DRUG OR ALCOHOL RELATED MESSAGES.
- 8. IF YOUR PROBATION IS IN ANOTHER COUNTY BESIDES SHELBY, YOU WILL NEED TO SIGN UP FOR THE VIP PANEL IN PERSON AND BRING A COPY OF YOUR SENTENCING ORDER WITH YOU.
- 9. YOU MUST PRE-REGISTER WITH PROBATION PRIOR TO THE VIP PANEL MEETING. IF YOU ARE NOT REGISTERED, YOU WILL NOT BE ALLOWED TO ATTEND.
